Analysis of the "More for More" model and its application to the three associated countries (Ukraine, Georgia, Republic of Moldova) in comparison with the three non-associated countries (Azerbaijan, Armenia, Belarus).

#### QUESTIONS FOR DISCUSSION

- 1. How effective has the "More for More" approach proved to be for structural reforms (rule of law, fight against corruption) in the associated countries? Was the financial support and market access provided by the EU a sufficient incentive to overcome the resistance of oligarchic interests?
- 2. Why, despite the "More for More" model, has "reform fatigue" emerged in some EP countries? What should be added to the "More for More" principle (beyond money and market access) to ensure the irreversibility of democratic change?
- 3. Should the EP policy after 2020 explicitly include a security and defence component for the associated countries (especially for the candidate countries) or does this go beyond the mandate of the EU's civilian policy? What is the main risk of ignoring the security factor?
- 4. How can the EU ensure that new priorities, such as the European Green Deal and the Digital Agenda, do not become an excessive economic burden for EP countries already struggling with poverty and infrastructure modernisation?

#### QUESTIONS FOR DISCUSSION

- 1. Should the EP policy after 2020 include a clear security and defence component for associated countries or does this go beyond the mandate of civilian policy?
- 2. How can the EU ensure that the reforms associated with the "European Green Deal" do not become an excessive economic burden for EP countries?
- 3. Despite many years of support, there is still oligarchic influence and much corruption in partner countries. What new, stricter mechanisms from the EU should be introduced to ensure that reforms in the rule of law and justice cannot be undone, even if political power changes?

- 4. How can the Eastern Partnership policy be changed to overcome "reform fatigue"? What new incentives (besides money) can be used to increase the involvement of civil society and local authorities, so that reforms are felt and supported "from the bottom up", not only at the level of central governments?
- 5. The new EU priorities (Green Deal, Digital Agenda) require large investments. With limited economic resources, how can the EU adapt these "green" and "digital" requirements so that they become a driver of modernization, not an additional burden for the EP countries?
- 6. Energy independence/resilience is essential for sovereignty. What forms of regional cooperation (e.g. common energy markets or transport corridors) between partner countries can be strengthened with EU support to reduce dependence on external monopolists?

- 3. How can regional cooperation (among EaP partners, e.g. in the areas of transport and energy) be strengthened as a tool to counter external threats?
